

I am Registered with the Health and Care Professions Council (HCPC); Associate Fellow of the British Psychological Society (BPS); Chartered by the BPS; and Chair of the BPS' Expert Witness Advisory Group, which advises on professional standards and good practice for psychologists working as expert witnesses. I have worked in a range of NHS mental health services since 2004, including several specialist psychological trauma services and an Occupational Health service, and have specialized in the areas of trauma/adversity and clinical risk since 2012. **I work with individuals across the lifespan** – with children, adolescents, and adults – and divide my time between NHS clinical practice as a Consultant Clinical Psychologist, expert witness work, and conducting and supervising research. I have worked as an expert witness since 2017 and am **instructed for claimants, defendants, and as a single joint expert**. I conduct expert assessments in relation to **personal injury (all types, including serious and catastrophic injury), clinical negligence, family law, immigration, and employment and work stress**. I have a professional doctorate in Clinical Psychology and a PhD that focused on assessment and evaluation. My doctorates, extensive clinical experience and training, and continuing professional development mean that I bring a breadth and depth of knowledge of psychological science and evidence-based assessment and practice to expert witness work.

CLINICAL RESEARCH & TEACHING

I have published ~20 articles on a range of clinical topics, many of which are on trauma/adversity and clinical risk. A full list of my publications can be found at my website (andysiddaway.com). My expertise in the field of trauma was recognised by two successive appointments to the Editorial Advisory Board of the *Journal of Traumatic Stress* (2017-2023) and an invitation to write a best practice guide entitled 'Assessment and diagnosis of posttraumatic stress disorders (PTSDs) for medico-legal and other clinical purposes: DSM-5-TR PTSD, ICD-11 PTSD and ICD-11 complex PTSD' for *BJPsych Advances*, the Royal College of Psychiatrists' continuing professional development journal for psychiatrists. I supervise Doctoral and Masters students and have provided peer-reviews for ~50 journals, including top-tier journals such as *American Psychologist*, *PNAS*, and *The Lancet Psychiatry*. I have been invited to grant review for the ESRC and act as external PhD examiner. I have extensive teaching/training experience in clinical and academic settings and increasingly present educational lectures on different aspects of expert witness work to psychiatrists and legal professionals.
